Critical and harmful access for owners, user block ability, Bugs, and vulnerabilities that enable theft of funds, lock access to funds without possibility to restore it or lead to any other loss of funds to be transferred to any party.

ERRORS, BUGS AND WARNINGS (medium, low severity): 0

Bugs can negatively affect the usability of a program, errors that can trigger a contract failure, Lack of necessary security precautions, other warnings for owners and users, warning codes that are valid code but the compiler thinks are suspicious.

Conclusion:

In the **FomoStake2** Smart-Contract were found no vulnerabilities, no backdoors, and no scam scripts.

The code was tested with compatible compilers and simulate manually reviewed for all commonly known and specific vulnerabilities.

So, **FomoStake2** Smart-Contract is safe for use in the Binance Smart Chain main network.

Independent description of the smart-contract functionality

The FomoStake2 smart contract provides the opportunity to invest any amount in BNB (from 0.025 BNB) in the contract and get 112% to 292% return on investment in 14 to 28 days if the contract balance has enough funds for payment.

- ✓ Dividends are paid from deposits of users.
- ✓ All dividends are calculated at the moment of request and available for withdrawal anytime or after the deposit finished time based on plans
- ✓ Each subsequent Deposit is kept separately in the contract, to maintain the payment amount for each Deposit.

Contract Owners Fee

Invest: 12%
Re-invest: 10%
Withdraw: 5%
Force-Withdraw: 20%



SIX INVESTMENT PLANS

Plans	Total Return	Daily Profit	Days	Withdraw time
1	112%	8%	14	Any Time
2	136%	6.47%	21	Any Time
3	140%	5%	28	Any Time
4	193%	13.71	14	End of Plan
5	275%	13.1%	21	End of Plan
6	292%	10.42%	28	End of Plan

- The minimum deposit amount is 0.025 BNB
- Plan's time and profit is float and change daily
- ** 10% of the withdrawable amount will be deducted on the withdrawing function, so the real total return is 10% less than the above table

Float Plans

After launch, each day plan duration and profit will change

- The daily profit of plans will increase 0.5% daily and it will increase to the maximum 3 times of the default plan daily profit.
- **Duration** of plans will decrease 0.5 days daily and it will be decreased to the minimum 5 day

Referral System (Match Bonus)

The contract pays an 8% referral commission over 3 levels

Level one: 5%Level two: 2.5%Level three: 0.5%

Notes:

• Users can get referral commission without deposit in the project but the user should have at least one deposit to activate his address and have access to withdraw referral commissions

Force Withdraw

Users can terminate a deposit and withdraw with an 70% penalty

- For plan 1,2,3 the user can terminate if a user does not withdraw his deposit
- For plan 4,5,6 users can terminate before the end of the deposit
- Distribution:
 - o 30% of the deposit will be transferred to the user wallet
 - o 20% of the deposit will be transferred to the secure wallet (owner)
 - o 50% will be remained in the contract
- Force Withdraw operate for each deposit separately

Re-invest System

Users can re-invest dividends of plan 1,2,3 and receive a 10% bonus.

- Only plan 1,2,3 can be reinvested
- * Reinvest bonus is 10% which will increase daily like plans daily profit
- ❖ The dividends and bonus amount of the reinvestment can be withdrawn at the end of the deposit plan.
