## High ISSUE

The system used is called ROI and must be considered as HIGH-RISK.

Users principal deposits can be withdrawn, users can get dividends and referral commission. Dividends are paid from deposits of other users. Do always invest with proper knowledge and investigation.

## Optimization suggestions

Loop on the dynamic variable (low severity).

If the user gets more parallel deposits his withdrawal transaction going to cost more transaction fee because the loop on the dynamic variable is used in the 'withdraw' function.

In case exceeding the GAS limit of the size of the transaction withdraw is not possible.

Note:

This comment is relevant only if a user creates an excessive amount of parallel deposits (more than 100).

Conclusion:

In the **BNBSTRONGERPLUS** Smart-Contract were found no vulnerabilities, no backdoors, and no scam scripts.

The code was tested with compatible compilers and simulated manually reviewed for all commonly known and specific vulnerabilities.

So **BNBSTRONGERPLUS** Smart-Contract is safe for use in the Binance Smart Chain main network.



**Independent description of the smart-contract functionality**

The **BNBSTRONGERPLUS** smart contract provides the opportunity to invest any amount of **BNB** in the contract and get a 30% profit on investment in 10 days if the contract balance has enough funds for payment.

- ❖ All dividends are calculated at the moment of request and available for withdrawal once a day
- ❖ Capital investment can be withdrawn at the end of plan
- ❖ Each subsequent Deposit is kept separately in the contract, to maintain the payment amount for each Deposit.

### Contract Owners Fee

Invest: 10%

### ONE INVESTMENT PLANS

Plans	Total Return	Daily Profit	Days	Withdraw
1	30%	3%	10	once a day

After 10 days, the principal investment will be available to make withdrawals or reinvest with 7% bonus.

- The minimum deposit amount is 0.05 BNB

### Referral System (Match Bonus)

The contract pays a 10% referral commission over 1 levels

- Level 1: 10%

#### Notes:

- Referral should be an active user; it means the referral address has at least one deposit
- The referrer is specified once at the time of the first deposit and is assigned to the user without the possibility of changing. From each subsequent Deposit, the referrer will get his percent.
- If a user has not had a valid upline, a total referral commission will be sent to the owner

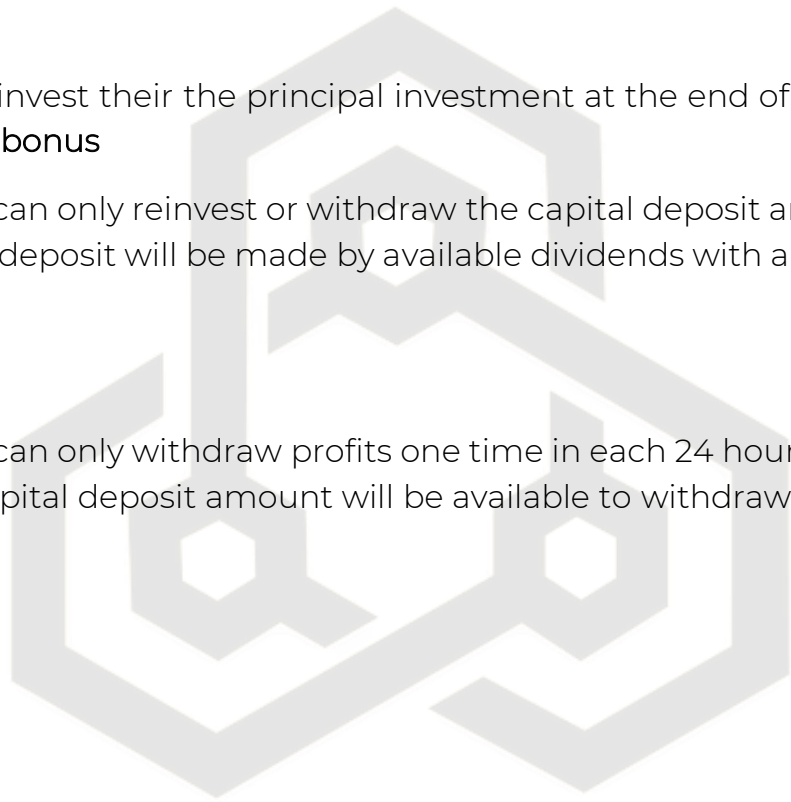
#### Reinvest

Users can reinvest their the principal investment at the end of plan and will receive a **7% bonus**

- Users can only reinvest or withdraw the capital deposit amount
- a new deposit will be made by available dividends with a 7% bonus

#### Withdraw

- Users can only withdraw profits one time in each 24 hours.
- The capital deposit amount will be available to withdraw at the end of plan
