## **HIGH ISSUE**

The system used is called ROI and must be considered as HIGH-RISK.

Users principal deposits cannot be withdrawn, users can get dividends and referral commission. Dividends are paid from deposits of other users. Do always invest with proper knowledge and investigation.

## **Conclusion:**

In the **BNBXFARMER** Smart-Contract were found no vulnerabilities, no backdoors, and no scam scripts.

The code was tested with compatible compilers and simulated manually reviewed for all commonly known and specific vulnerabilities.

So **BNBXFARMER** Smart-Contract is safe for use in the Binance Smart Chain main network.

## Independent description of the smart-contract functionality

The **BNBXFARMER** smart contract provides the opportunity to invest any amount in BNB (from 0.01 BNB) in the contract and get 119% to 239% return on investment between 7 to 30 days if the contract balance has enough funds for payment.

- ❖ All dividends are calculated at the moment of request and available for withdrawal anytime
- ❖ Each subsequent Deposit is kept separately in the contract, to maintain the payment amount for each Deposit.

### Contract Owners Fee

Owner Fee: 10%

### 24 INVESTMENT PLANS

- Plans duration start from 7 days to 30 days. For example 7, 8, 9,10, etc
- Plans total return start from 119% and increase 5% based on the increment of the duration of the plan. For example plan, 7 days has 119% total return and plan 8 days has 124% total return.
- The minimum deposit amount is 0.01 BNB
- Users can withdraw anytime
- Each address can have a maximum of 100 deposits

## Referral System (Match Bonus)

The contract pays an 11.5% referral commission over 5 levels

- Level 1: 5%
- Level 2: 3%
- Level 3: 2%
- Level 4: 1%
- Level 5: 0.5%

Notes:

- Referral should be an active user; it means the referral address has at least one deposit
- If the user has not had a valid upline, the owner will be set as default upline.

## Fake Turnover

Two functions will be used to make fake turnover for the contract. It will be used to get a better rank in monitoring websites.

Functions:

- Invest()
- Invest(amount)
